Natural Human Development

In Natural Human Development the individual is shown as progressing through a series of (*Spiritual*) *Initiations*. These Initiations are recorded in the BIBLE – in fact the BIBLE is littered with indications of Initiation. In numerology the number **40** is the "period of initiation"/teaching and testing - i.e. the neophyte* fasts, meditates, is instructed and prepares himself/herself for Initiation over a period of **forty days!** **Forty** is mentioned in the BIBLE a number of times – at important points. * the person to be initiated

Just some of the examples of Initiation, as they appear in the BIBLE, are;

- 1/ JESUS fasted in the Judaeen Desert for forty days and forty nights where he was tempted by the DEVIL three times,
- 2/ The ISRAELITES wandered around the Sinai Desert for **40** years before being led to a land "flowing with milk and honey" ** &
- 3/ NOAH was on the Ark when it rained for 40 days and 40 nights in The Flood.

** reference to the land flowing with milk and honey is an allusion to Initiation

In all of these instances an Initiation was taking place and the particular Initiation in the last instance, for **NOAH**, is called the 4th Initiation, 2nd MAJOR Initiation*** or HYPERLINK "<https://en.wikipedia.org/wiki/Arhat>" \l "Meaning_of_Arhat" Initiation to become an Arhat – with all of these names/descriptions being equivalent (see <initiatoryFRAMEWORK.pdf>). You'll note that Noah's craft, the Ark, came to rest on Mt. Ararat. Arhat (*the Initiation*) being a derivation from the word Ararat! This presumption that this is the 4th Initiation is because of NOAH's prominence on the world stage. The account pertaining to the ISRAELITES is most likely pertaining to some of the members of the tribe becoming Shaman/Shamanesses but it could be the lead-up to **MOSES'** 4th Initiation too. This event, of wandering around then coming out of the Sinai Desert, should be more properly regarded as indeterminate though. Sometimes it can be deduced what occurred from inferences in the account of the incident but there is little to go on here. JESUS' temptations by the DEVIL is dealt with later in this missive – 2nd paragraph of the following

page. (Note that the word **EVIL** is presented if the first letter "D" is eliminated.)

Also there is a science called [Gematria](#) and the whole BIBLE, which was initially written in Greek, conforms to this science I understand. In Gematria each letter is assigned a numerical value, according to their position from the first letter of the Greek alphabet (α), following the principles of numerology. These values are then added for each sentence. If one sentence in the (original Greek) BIBLE has the same (numerical) value as another sentence then both sentences have *similar* same meaning – no matter that these sentences appear in different parts of the BIBLE or if the (overt) meanings differ. I don't know if the normal allowance of a "[colel](#)" in numerology is applicable with Gematria – i.e. the two integers either side of the number mentioned are considered the same number. This nuance is of no consequence, however, because the science of Gematria isn't necessary for the level of understanding of the BIBLE I have developed my case on. Gematria has been mentioned to draw attention to the fact that the BIBLE has quite a bit more to it than is presented.

I have read that JESUS accomplished three Initiations in 3 (or 4) years – i.e. the 2nd, 3rd (Shaman/Shamaness) & the 4th (Arhat) - see <[initiatoryFRAMEWORK.pdf](#)>. JESUS undertook the 1st Initiation when he was baptised by JOHN THE BAPTIST. I assume that he undertook the 2nd Initiation when he was tempted three times by the Devil in the wilderness (Judaean Desert). The number **40** is associated with each event. He was also taken up on a mountain after these two events and this is where he was initiated as a Shaman/Master Shaman I believe. Lastly his crucifixion was the 4th Initiation. (*Its all made up anyway – lots of people know the 'recipe'. The 'evidence' are accounts which are written decades later!*)

Previously I understood, from my research and reading when I had my Nervous Breakdown some 30 years ago, that the MAJOR Initiations were composed of two components, a **Physical Component** and a **Spiritual Component**. I think I read this in a book authored by [Alice Ann BAILEY](#) – but I can't remember which one (of the 24 books she authored). This **Physical Component** part of the Initiation I understood as just that – **PHYSICAL!** This threw me as I was told, by the Reverend of the Christian Spiritualist Church I was attending at in early 1988, in a reading that I was to, "**Cross a desert – but not to worry because I will be taken up on a camel.**" At the time I didn't understand that there was anything of note about this reading. I remembered that I was very depressed for the Monday and the Tuesday following the church service and on the third day the depression eased somewhat. I also remembered that I only picked up a little mentally a few days before this reading on the Sunday. Mentally I was struggling really hard with depression around this period!

Sometime later (approximately a year later I'd guess) I came to understand that this is when I was initiated (or so I thought), because **I experienced severe depression** - much more than normal, **for three consecutive days**. I knew that 'the whale dream' went for three days, where Jonah became a Shaman – from the paperback book *titled* "ISIS UNVEILED". The Jungian Analyst mentoring a few of the psychologists from the Psychotherapy Centre of Wollongong Hospital, gave a presentation about a woman who had this very extreme experience, at a Jung Society of Illawarra monthly meeting in the mid-80s. Although this Jungian Analyst did not state that this extreme experience of the woman was significant the very fact that this presentation was given by him, *a Jungian Analyst*, makes it significant. Some weeks after the presentation, I cottoned-on to the fact

that the experience the woman had endured was very similar to my own - we were doing the same/a similar thing!

About a year or two after that reading at Spiritualist Church, very late in the 1980s from memory, I had a dream involving a deceased native American (red Indian) healer called BLACK ELK who told me, "**Now you are a complete Shaman.**" I wondered about this dream because I thought I was already a Shaman.

It wasn't until I began to write a chronological account of my experience in early 2010, hereinafter called **the (notorious?) 'letter'** ^o, that I began to understand the true significance of the **Physical & Spiritual Components** of the 1st MAJOR Initiation. I'd already understood that something was going on in [Near-Death Experiences](#) because I'd read a book which listed about 10 fairly common factors in **Near-Death Experiences** – this book also stated that FOUR OF THESE FACTORS WERE **EXCEPTIONALLY** COMMON! Something had to be the driving force for/behind this as repeated similar observations have a cause! I guess I worked out that this **Near-Death Experience** was associated with the 2nd MAJOR Initiation but I hadn't realised that my three consecutive days of depression, in early 1988, were just the **Physical Component** of the 1st MAJOR Initiation. It **all-fell-very-neatly-into-place** quickly though and that dream in which I misunderstood the significance of, involving BLACK ELK, was obviously when I received the **Spiritual Component** for the 1st MAJOR/3rd Initiation! (*Apparently usually the **Spiritual Component** of each Initiation is conducted first with the **Physical Component** following – I'd done this 1st MAJOR Initiation in the reverse order!*)

This **Physical Component** for the 1st MAJOR Initiation (3rd Initiation - Shaman/Shamaness) corresponds to the three day experience of being swallowed by a whale and later disgorged (*on to dry land*). This is an allusion to the classic death/rebirth experience! I clearly remember this EUREKA MOMENT when I'd read in this paperback book titled "ISIS UNVEILED", authored by Helena BLAVATSKY (and possibly re-written by Bodo BALSYS), that Jonah became a Shaman because of the whale dream – the three day experience in the belly of the whale. **Before this I hadn't understood that spiritualism and religion were linked in any way!**

An example of the **Physical Component** of the 2nd MAJOR Initiation (4th Initiation – Arhat) is Michael SCHUMACHER's snow-skiing accident. Always look for the oddity – this guy had a very dangerous occupation, along with being a vulcanologist or a lion-tamer, and he can't even take his kid on holidays without hurting himself! This **Physical Component** for this 2nd MAJOR Initiation can be accomplished in sickness as well as injury though - all that is required is the person experiencing a coma for several (10 →12) consecutive days, and recovering from the experience - although this may not always be the case. [That woman who was lost in the hinterland near Innisfail for 17 days may not have been in a coma at all.](#) Perhaps it might be safe to assume that there was a period of coma of much shorter period, say a day or two, necessary to complete the Physical Component of the 2nd MAJOR Initiation.

Another example of the **Physical Component** of the 2nd MAJOR Initiation is Nathan OUTERIDGE's car crash travelling to a regatta on Port Phillip Bay. [This guy breaks his back in this car crash and he goes on to not only sail again but he becomes Olympic Champion of the 49er Class in the London Olympics!](#)

the (**notorious?**) 'letter'

Some nutter psychiatrists, from Illawarra Shoalhaven Local Health District (ISLHD) in NSW (Australia), locked me up (Involuntarily Admitted me to public-hospital psychiatry wards) for SUPPOSEDLY being Mentally Ill almost 9 years ago now – see <[TIMELINE.jpg](#)>. The word (**notorious?**) was added to the description of the 'letter' by the barrister I engaged to represent me in seeking my release. I think that he was making a **tongue-in-cheek comment** about this 'letter' and the **CRAZY JIHAD conducted by these public-hospital Psychiatrists** from the Illawarra region of NSW, Australia!

In NSW someone is Mentally Ill if they have a (serious) Mental Illness coupled with there also being a "reasonable belief" that this person will either seriously harm either themselves or someone else (or both) – refer to [NSW Mental Health Act 2007 No 8, Section 13 & 14](#). This 'letter', according to the copper in charge of 'the case' (Senior Detective Jayson GAL), was judged by him to NOT contain any direct or implied threat and he stated this in his missive to the 'Dogs of War' - Wollongong Community Mental Health Team (WCMHT) psychiatrists & staff. *(When the 3 police officers took me from the front door of my home to the Emergency Department of WOLLONGONG HOSPITAL this is all they had on me – apart from their 'observations' at my abode!)*

Other people had different attitudes than this detective to this 'letter' - see directly following.

The Many Faces of the (**notorious?**) 'letter'

- A/ I was asked for a file, the 'QUICK QUIZ'^{oo} referred to in this (**notorious?**) 'letter', by the barrister after he'd secured my release from the 'nut farm'.
^{oo} a tongue-in-cheek presentation of the info, in [Janine SHEPHERD's](#) Australian Story "[Taking Flight](#)" on ABC TV, using questions
- B/ The psychologist I employed to provide Expert Evidence for the court case I instigated to seek damages In The Supreme Court of NSW (Common Law Division) – File #2012/237593, asked me to **summarise** the (spiritual) information I presented chronologically in the 'letter' [*About 1½ years after I initially wrote I this **SUMMARY** - in Landscape, SpreadSheet form {the file <[initiatoryFRAMEWORK.pdf](#)> is a development/refinement of this **SUMMARY**}* - **I suspected that the CHAKRAS were somehow involved in these Initiations** (see [Page 7](#) of this file and the image <[circledCHAKRAS.gif](#)> - Page 8).]
- C/ I went to Theosophy House in Sydney CBD and asked for the staff there to evaluate the (**notorious?**) 'letter', for the court case – i.e. have them provide Expert Evidence. MY FRIEND AND I WERE ESCORTED OUT OF THE BUILDING!
*(I think that this missive was distributed far and wide! The psychiatrists
 (and coppers would not have understood a large part of this 'letter' – it)
 (would've been Rocket Science to them so they'd have to ask someone!)*
- D/ I sent an earlier version of the file <[initiatoryFRAMEWORK.pdf](#)>, the spread-sheet presentation developed from the (**notorious?**) 'letter', to the [headquarters of Theosophy in Wales](#) and received an advancement in my spiritual progression within a week. I hate dealing with Australians – see Point C/.

E/ I asked about **the (notorious?) 'letter'** every time I was 'interviewed' by the Psychiatrists. (I knew that their interest in me, stemming from the **'letter'**, was unwarranted.) They never replied! Right at the end of the 2nd Incarceration, in an 'interview' conducted by two Psychiatrists one of them asked me, "**Where did you get the information** (in the **'letter'**) **from?**" I told them and when I was unsure about the current name of this particular bookshop the other Psychiatrist stepped in. The fact that this very senior psychiatrist, Dr. Roger WENDEN (since retired), was able to sort out the problem of the bookshop's name indicated that he was aware of this bookshop and its location! One might also wonder why these psychiatrists conducted TWO interviews on the last day! All-of-a-sudden they had increased the level of 'care' I was receiving OR was it really just about gathering more ammunition, to use against me, for the following-day's hearing where I'd engaged a barrister to represent me? (*conflict-of-interest*)

Of course you'd think that the simplest, and most logical thing to do would be to ask the author (me) about this 'letter'. The person who wrote any particular missive should be able to explain just what was intended! I make the logical assumption that the psychiatrists would use their 'interviewing' time to question me about this letter but this was not ever done with respect to the intention of my 'letter' – except for Dr. HEARPS on 18/5/2010 at my home and before I was locked up the second time, by Dr. LAL, again at my home, to get me locked up again!

All that was done, with respect to **the (notorious?) 'letter'**, was to use in as dramatic manner as possible to influence the magistrate into extending my False Imprisonment! How the system (psychiatry) works is that you are just continually re-Scheduled as Mentally Ill without any regard for your well-being! The reason for the person being initially Involuntarily Admitted becomes immaterial. You are referred to the **Rosenhan Experiment** for support to my contention of psychiatrists getting it wrong. My understanding is that the psychiatrists want you to take their "YIPPEE BEANS" on discharge from the hospital and the fact that you follow this directive means that there was a need for 'the medication'.

I told this Psychiatry Registrar (trainee Psychiatrist), from the other public hospital mental health facility in the Illawarra region, before my admission to WOLLONGONG HOSPITAL Mental Health Inpatient Unit the first time, "**THIS IS ONE FLEW OVER THE CUCKOO'S NEST**", with respect to what was going on concerning my *about-to-become-real* Involuntary Admission. His response was, "**We've improved a bit since then.**" I think that he should have asked for a Second Opinion – NOT from a fellow psychiatrist though! (I was held in the secure section of the Emergency Department of Wollongong Hospital for at least an hour waiting for this trainee, Dr. EDIRIWEERA, to 'interview' me. He didn't write any report! I was being gawked at like would happen in a zoo!)

The Clint EASTWOOD directed movie, starring Angelina JOLIE titled "**CHANGELING**", is another exposé of the arrogance of psychiatrists and this film also evidences the unholy link between them and police. In practice its just "Thoughty* Crimes"!

* the "y" was initially a typo but I decided to continue its use to demonstrate the childishness of Psychiatry

F/ The whole incident concerning the two Involuntary Admissions was sent to the Health Care Complaints Commission (HCCC) for their evaluation to determine if the Psychiatrists concerned, should be charged CRIMINALLY with Assault, Battery and False Imprisonment. According to the HCCC, Internal Medical Advice and a peer-Psychiatrist, can overturn a judgement of a Magistrate. As a result of this I tell people, **"Get ready for the creeping CALIPHATE of PSYCHIATRY!"**

Also the Health Care Complaints Commission made the point that they considered what I did was "inappropriate"! I tell people that I'd heard of the 'Fashion Police' and the 'Thought Police' but I'd never heard of the 'Appropriate Police' before!

The HCCC determined that something I'd written about in, **the (notorious?) 'letter'**, was terrible. On this I have agreement AT LAST with the HCCC under certain conditions! If you extracted the phrase from the sentence it was in and relied on just this for a judgement of my mental makeup, AND also ignored the rest of the paragraph AS WELL as the paragraphs preceding and following AND the general tone of the **'letter'** one could arrive at the HCCC's determination! I'm making the point that the HCCC was more than highly selective in arriving at their 'opinion'. THE REALLY TELLING THING ABOUT, **the (notorious?) 'letter'**, was that there was NO QUESTIONS* from the "peanut gallery" about this **'letter'** at the 'interviews' during my incarcerations! You'd think that anyone ascertaining a person's Mental Makeup (i.e. the Psychiatrists) would make sure that there was a problem in the first place rather than solely relying on their 'expertise'! **Observation is the first principle of any science!** Of course if you make the presumption, that the **'letter'** provided these psycho Psychiatrists with what they wanted, then NO FURTHER INQUIRY WAS NECESSARY! * *excepting paragraph 1 Point E/*

I guess I should not have thought that the HCCC would NOT do anything effective after watching that television exposé about Suresh NAIR and the fact that him practicing as a neurosurgeon was finally revoked ONLY after he was involved in the cocaine-related death of a 2nd prostitute! (He was eventually deported - the HCCC did nothing!)

I am what is termed a "**Psychiatry Survivor**". One of the vast group of people who have been unfairly targeted and 'treated' by psychiatrists and lived to tell the tale! All I experienced from the medical staff^{ooo} from Wollongong and Shellharbour Hospitals as well as the Consultant Psychiatrists, at the time, was CHARACTER ASSASSINATION. Whatever I told them was twisted in the worse possible way to make me look bad! From my experience with psychiatry I would call it Medical Fascism because in a Democracy I have the right to choose my own fate as long as I do not infringe on another, and as an example if I have serious cancer - including terminal cancer, I have the right to refuse treatment! Some time ago I investigated this proposal, **that the CHAKRAS were somehow involved in these Initiations**, and I have inserted the results, into the SpreadSheet – the <[initiatoryFRAMEWORK.pdf](#)> file. This file is a development from the initial **summary** I produced for the retired psychologist, who I employed to produce the Expert Evidence for court. He made this request for a **SUMMARY** after studying my **'letter'** for the production of his Expert Evidence for the court case.

The involvement of the Chakras, see www.NaturalHumanDevelopment.com, fits neatly with what I previously knew about these Initiations – there being 9 Initiations all told available for humans. There is a block of 5 Initiations, called **MAJOR INITIATIONS**, in the centre preceded by two preliminary initiations known as **Minor Initiations** leading to this block of **five MAJOR INITIATIONS** and then progressing on to two higher initiations, which are called **Solar Initiations** – see <[initiatoryFRAMEWORK.pdf](#)>.

Why these Chakras are important is that enlivening each of them gives the individual amazing powers. While it is not necessary to go into detail for each particular Chakra enlivening of the **Heart Chakra** produces, "***the Birth of Christ consciousness in the cave of the Heart***". (Psychiatrists call these '*Religious Delusions*'.) Enlivening the next Chakra above this, the **Throat Chakra**, allows the person to be **ClairAudient**. The next Chakra, the **3rd Eye or Brow Chakra**, allows the person to be **ClairVoyant** as well.

I am not a New Age type of person. I have a **Degree in Metallurgy** and for my thesis I researched so avidly my mentor asked me to provide him with a photocopy of published research "papers"* I was sourcing through inter-library loans. I only started analysing **Dreams** early on (about 1983) when I had my Nervous Breakdown because I witnessed my psychologist analyse someone else's dream during **Art Therapy Class**. What I knew about the person, the dream he had and my Jungian psychologist's interpretation of his dream all seemed to gel and make sense. I began to read about **Dreams** and their interpretations, with much interest, as well as keeping a Dream Journal for about 5 years! Early on I became a bit slack in recording my dreams but this changed after I attended a lecture/presentation given by the Jungian Analyst mentoring some of the psychologists at the Psychotherapy Centre of Wollongong Hospital. John JANSEN mentioned a suicide at his Community of Living Water centre in the Blue Mountains (at Lawson in NSW) and how he wished that he had been told about a dream, with alarming content, which would have had him intervene to cease the Rebirthing treatment the client was undergoing.



My educated guess is that humans can only endure this amount of enlivenment of the Heart Chakra, Throat Chakra and 3rd Eye/Brow Chakra OR any combination of these Chakras - at any given time!

TREATMENT

I don't use Psychiatric Terms because they don't aid in any proper treatment. Basically the troubled person is distressed because their SUB-conscious is 'bubbling up' - coming to the fore. My Jungian psychologist explained the scenario using the [Myth of the Medusa](#). You'll recall that the Medusa, a mythical woman with snakes in her hair, was able to turn men into stone who looked at her. In the myth to slay this beast one needs to use a mirror and strike her with a sword using the image of her reflection to aim the sword. The reflection is an allusion to Dreams* - or some other SUB-conscious technique (hypnotherapy, meditation, [Art Therapy](#), etc.). The phrase "turn men to stone" is the problem of addressing big change through the conscious mind - one is rendered powerless or immobile!

* Sigmund FREUD said that Dreams were - "[the "Royal Road" to the unconscious](#)".

Therefore, a technique which addresses this matter will be the only realistic solution to the problem. About two and a half millennium ago, in (ancient) Greece, the first Temple of Asclepius was built and the priests of the temple conducted a process known as incubation. [In this process the patient spends the night at the temple. During the night the patient would be visited by the god \(of the temple\) in a dream. Priests would then interpret the dream\(s\) and prescribe treatment.](#)

I have never heard a Psychiatrist ever mention the word SUB-conscious! It seems that there is never any consideration of it in their so-called SCIENCE?

N.B. Just one more problem I have with Psychiatry is that it ignores Scientific Theory. In cosmology there is a theory called M-theory. M-theory involves the presumption that there are an infinite number of dimensions. Support for this theory comes from dreams - particularly 'Wet Dreams'. Another person(s) is actually there - in Astral Body form (in the Astral Dimension of course).

People have given accurate accounts of what's happened during their Near-Death Experience (NDE). My understanding is that the person experiencing the Near-Death Experience has witnessed their 'lifeless' (physical) body from their Astral Body.

The model of not existing unless it is present in the Physical Dimension, i.e. a psychiatrist calling non-physical occurrences "hallucinations", is overly simplistic!

If you view the NSW Mental Health Act 2007 No 8 inspecting the Definition of a "[Mental Illness](#)" you'll understand the stupidity of the drafters of the MENTAL HEALTH ACT for NSW. Every Psychic in NSW has a Mental Illness according to our polities because they are experiencing "[3\(b\) hallucinations](#)"** - seeing things which aren't (physically) there! Of course the situation is easily understood if M-theory from cosmology, where there are an infinite number of Dimensions, is applied. The Psychic is simply accessing information from another/other dimension(s)!

I have a degree from the University of Wollongong. My degree is in an Applied Science called Metallurgy. You'd think that my scientific training would allow me to recognise Scientific Principles in other sciences but I can't discern any science in Psychiatry at all! To me Psychiatry is just the Psychiatrist(s) insisting that their OPINION, which they call a diagnosis, is supreme and all other opinions should be disregarded. Psychiatric disasters are ignored by them and most people will remember [Chelmsford Private Hospital](#). One of the few people prosecuted over this fiasco was the barrister representing the

victims – he questioned the defendants too aggressively apparently – and people died! An even greater Psychiatric Disaster was the practices of the American Psychiatrist – Dr. Walter FREEMAN - [this idiot conducted lobotomies on about 3,000 people!](#)

The performance of the Psychiatrists during my False Imprisonments about 7 years ago (see <[TIMELINE.jpg](#)>) was akin to the Solicitors defending the court case I instigated against them in The Supreme Court of NSW, Common Law Division, File No 2012/237593 – with one difference. Somehow the Psychiatrists had the added power of being able to convict me for “thought crimes”! In court someone is required to actually PROVE that a crime has been committed but a Psychiatrist simply has to state the “thought~~y~~ crime” for it to be considered a real probability! If ever I have to defend myself against a Psychiatrist(s) for “thought~~y~~ crimes” I’ll employ a Z-grade Psychic to deal with these IMAGINARY “thought crimes” and this should be allowed because I have found them to be more accurate than Psychiatrists!

I allege that the OPINIONS of the psychiatrists during my False Imprisonments about 7 years ago, [that I would harm someone other than myself according to the definition of a Mentally Ill person in the NSW Mental Health Act 2007 No 8](#), was allegedly a directive from the new Chairman of the Board of BHP Billiton - Jac NASSER. If you note the day of the commencement of my first False Imprisonment was the 2nd of April in 2010 - see <[TIMELINE.jpg](#)>. Jac was appointed Chairman of the Board of BHP Billiton [two days earlier](#), on the [31st of March in 2010](#), and I have a very large dispute with BHP Billiton over the rights to an invention which is **worth a lot of money!**

I contend that we don't in fact live in a democracy if this barbarism is allowed to continue!

If you've ever hear a Psychiatrist “sell” Electro-Convulsive Therapy (ECT) they say, **“We only use ECT when all other methods have failed.”** (*I've never heard a greater truism.*) Basically all Psychiatric Techniques are a complete and utter failure so every patient will progress on to the ‘last resort’! [View a friend of mine's web-site when these psycho psychiatrists attempted to have his 75 year old Mum ECTed!](#)

Another thing is that there always seems to be some urgency with commencing the ‘treatment’. I think that this is because these Psychiatrists don't want the prospective ‘psychiatry survivor’ to check with other people about the efficacy of psychiatry. I find the things which come out of their mouths quite facile.

“Hearing voices” is not a new phenomenon. You'll recall that [Joan of Arc](#) heard voices which guided her to speak with the future King of France to drive the English out.

ADDENDUM

G/ An omitted incident concerning **the 'letter'** should be included for balance about its content. When I was transferred to SHELLHARBOUR HOSPITAL's high intensity psychiatric ward, Elouera West, on the Tuesday after my initial Involuntary Admission (6/4/2010) I was left in an interview room just outside the ward and the nurses were laughing over the content of **the 'letter'**. They thought that the comments about my sexuality late in **the 'letter'** were amusing! Staff from the same establishment had totally differing views on **the 'letter'** and unfortunately the admitting nurses were not given the decision to either detain or release me! (I was being facetious – its almost always downward pointing thumbs from these Caesars, without any input from the crowd!)

E/ Page 5, end of Paragraph 2

When Dr. LAL asked me about **the 'letter'**, during the very brief 'consultation' (est. 5 min.) when he was exercising the Examination Order[^] on the 11th of June in 2010, I was most cautious in answering him. The matter of this letter had already been considered in determining my fitness for release into the community at the hearing almost two months before and therefore I was wary about Dr. LAL wanting to pin something on me! I made no answer and this lack of response was treated in the usual damaging psychiatric manner in that it was called a "**Non Sequitur**" by Dr. KHALID in the hearing at the conclusion of my second Involuntary Admission (17/6/2010). The barrister at this hearing called **the 'letter'** ANCIENT HISTORY! - because it had been written almost 3 months previously, and handed to the café proprietor then. (This **'letter'** wasn't positively acted upon for two weeks after receipt by the café proprietor anyway!)

Dr. LAL didn't even sign the Schedule 1 form! I was locked up for a week as a consequence – ILLEGAL FROM THE START! Also there was quite some written input on this Schedule 1 form about this **'letter'** and there is the possibility that this part of the form could have been completed before the interview with the psychiatrist Dr. LAL even commenced!

KGB

I call these Psychiatrists 'the KGB' because I had a number of 'encounters' with a Senior Psych. Nurse, who I'd nick-named "**Nurse Ratched**" (see Page 15 - <[nurseRATCHED.pdf](#)>), after I began complaining to various politicians. Also the address of the new home I was renting was recorded on the back of the Medical Records AND I DIDN'T MOVE INTO THIS HOUSE UNTIL MORE THAN A YEAR AFTER I'D BEEN RELEASED THE LAST TIME! (*I still don't have a Criminal Record!!!!!! – early 2019.*)

Last hearing to determine fitness for release into the community - 17/6/2010.

The Psychiatrist, representing WOLLONGONG HOSPITAL (Dr. KHALID), made much of the fact that I did not consult with a Psychiatrist when altering the prescribed 'medication' which was required by the Magistrate hearing the case ending my previous admission on 22nd of April in 2010^{^^}. I only saw a doctor who told me to reduce the 'medication' to half and once the quantity issued was consumed to not go back on it.

^^ You'd think that the court would issue **written orders!** (poor practice)
(rather than verbal ones to a possibly drugged-out-of-his mind "victim")

The Magistrate hearing the case, on 17th of June in 2010, allowed me to see my doctor and have him determine if I needed to see a Psychiatrist. Not consulting with a Psychiatrist after the first admission was a technical breach of the Magistrate's (verbal) orders but as I was allowed to have my doctor determine the necessity, or not, for me to be referred to a Psychiatrist after the second admission it was not a major fault. As usual this minor breach was blown out of all proportion by a Psychiatrist!

I'd rather be treated as an alleged Common Criminal because then I can only be interviewed in the presence of a Legal Aid/my solicitor AND these interviews are video-recorded. There are certain procedures that need to be complied with and 'unsigned confessions' are no longer allowed to be submitted as 'evidence' that the alleged criminal has admitted to the crime. *(I don't put these Psychiatrist records-of-interview up there with the status of 'unsigned confessions' though because the Hospital/Medical Records are really what the Psychiatrist(s) (et. al.) have wanted as a record of the 'interview'. Likely the being-loaded-up victim would be at least shown the 'unsigned confession' by the interviewing police. And there is the 'messy' for the police problem of a solicitor being present! The victim/patient is not allowed to see his/her own Hospital/Medical Records so he/she is completely in the dark as to what he/she is defending himself/herself against!)*

Misusing this Scheduling procedure is economical for Coppers though. They don't have to plant 'evidence' on the 'suspect'! Indeed, no crime needs to have been committed!

Such legal niceties as interrogatories, where the opponent solicitor requests an answer(s) to a specific question(s) to streamline the court procedure, are of course avoided with Psychiatry. The only "paper trail" is theirs which is called the 'Hospital/Medical Records'.

I was amazed that after a week of being Falsely Imprisoned all I had was a business card from the Wollongong Community Mental Health Team with the words, "**We need to see you**", written in biro on the reverse side and a printed-on-both-sides A4 sheet of paper with laying out the **Statement of (my) Rights?** THIS IS A DEMOCRACY???

How can any profession avoid this inference if they have opposed the release of a person? The police are allowed to do this but they are not (supposedly) involved in treating the person! The Psychiatrists are charged with treating the person whilst still acting, in effect, as their jailers!

I DON'T THINK THAT ANY INVOLUNTARY ADMISSION, TO A DECLARED MENTAL HEALTH FACILITY, SHOULD BE ALLOWED WITHOUT JUDICIAL OVERSIGHT BY LAW – see <[involuntaryADMISSION.pdf](#)>. If the person is detained for a period of in excess of 4 hours before a Magistrate can give this order then they should be released – by law. This would stop them from having me locked up on a Friday night, as what occurred twice, see <[TIMELINE.jpg](#)>.

The Mental Health Act is almost completely meaningless in operation as it is so easy to get around. I have many other recommendations for improvements to this Act too!

The worst allegation is that my original '**letter**' was altered as I had this missive printed off and before I handed it to staff on the 2nd evening of my 1st incarceration each copy had my handwriting with the date written on the top of each page. The Medical Records indicate that another '**letter**' was delivered to the Mental Health Inpatient Unit of Wollongong Hospital and this other '**letter**' was not supplied with the Medical Records!

UNWARRANTED INTEREST

13/2/2016

After I had been released from Involuntary Admission on two occasions in 2010 I was surprised to find my new address on the back of a page, at the top of this page. I didn't move to this new address until well over a year after my release from the 2nd False Imprisonment. The likelihood that I'd become Mentally Ill at this point was just so miniscule – especially when I admitted that I'd had a Nervous Breakdown some 30 years before AND NOT ONLY GOT THROUGH THIS PERIOD BUT RECOVERED WITHOUT HARMING MYSELF OR ANYONE ELSE SURELY IS SOME INDICATOR TO MY SELF-CONTROL. Apparently the Psychiatrists thought otherwise or wished to take this view.

Additionally, after the court case was settled, In The Supreme Court of NSW, Common Law Division, File No. 2012/237593, I went to my local state member's electoral office in the company of my friend who has a law degree. The visit was over me calling the Senior Detective in charge of the case* an idiot in correspondence and afterwards having a Wollongong Community Mental Health Team (WCMHT) business card inserted into my front screen door! If you think that there was a genuine concern for my mental condition from the WCMHT staff then we are in disagreement!

* there was no (actual) case – nothing happened!

FURTHERMORE

I have supplied detailed information on what is actually occurring when someone is suffering from a Severe and Chronic MENTAL HEALTH PROBLEM (S&CMHP) to Wollongong and Shellharbour Hospital mental care units as well as the WCMHT. In my opinion I wasted my time as I was treated in a most unwelcome manner. I think that Mental Health Care is an ABOMINATION and it appears to me that this is just fine with most mental health professionals.

STILL MORE – 13th March, 2016

I shifted house early the following year after my Discharge from my False Imprisonment on the second occasion - 17/6/2010. My new address was written on the back of the Wollongong Community Mental Health Team records. What is the WCMHT – the KGB?

31/5/2016

I was released twice for Escorted Leave, for a number of hours, during my first Involuntary Admission. As I was Involuntarily Admitted because I was Mentally Ill as well as the supposed problem of me suffering from one of their fictitious mental problems there was also the problem of me being likely to seriously injure either myself or someone else. This Escort was just one of my friends and so there was the possibility that I could give him the slip and either injure myself or someone else – although there is a 'rider' on this in that IF the 'medicine' (chemical cosh) was effective then my being Mentally Ill was temporarily overcome and I was therefore safe to be granted escorted leave. (16/3/2017)

The only objective I can understand that the senior staff of the Declared Mental Health Facility, The Wollongong Hospital Mental Health (Inpatient) Unit, granted me this Escorted Leave was that they were hoping that I would abscond. If I was being held because they thought I was Mentally Ill then I should have been kept locked up most people would think! (16/3/2017)

J. about it and identified him to A. J. at about 12:40pm when he was at the table where the fountain was.
